Financial Feed Enhancements & CPI Scores Increase the Scope of Monitoring Data

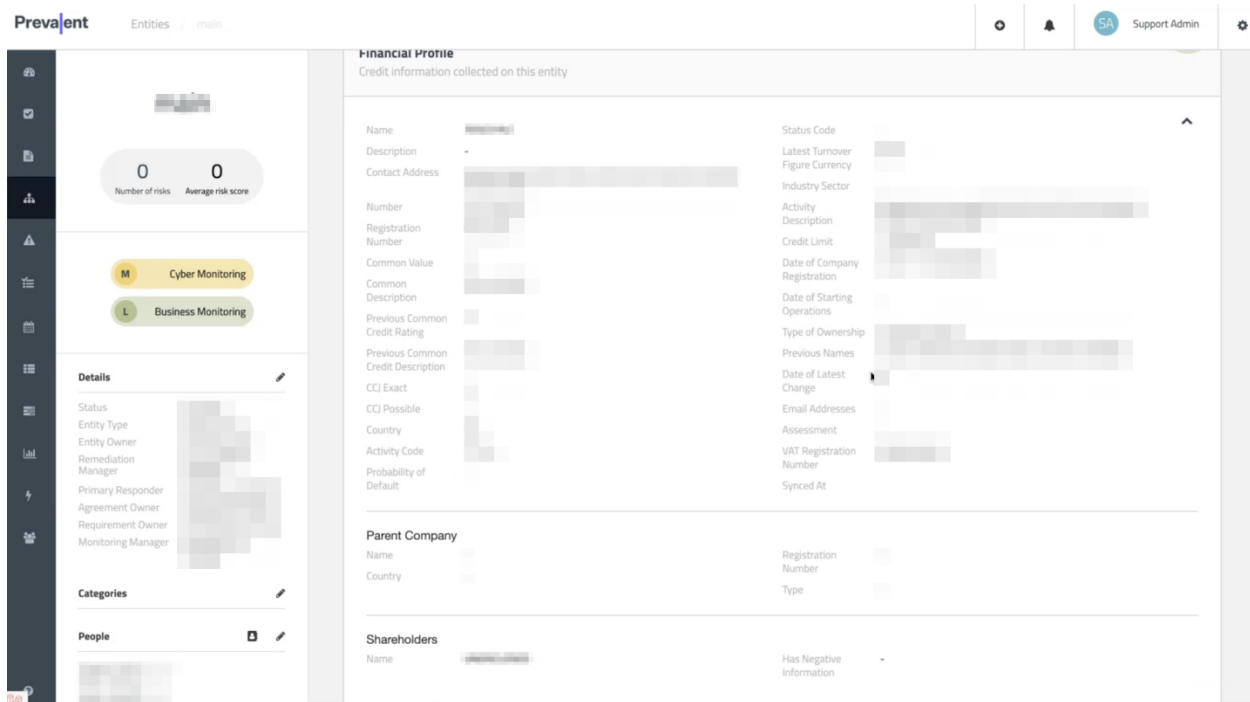
